### Article 3 Section 6 Membership Dues

Dues are \$20.00 per year and due as of April 1<sup>st</sup> of each year. The initiation fee is \$20.00 and payable at or before induction as a member.

### Article 3 Section 7

Any member who shall be two (2) months in arrears in dues shall be notified in writing by the trustee, that if he is not fully paid-up thirty (30) days from the date of this notice, he shall be automatically expelled from this association and deprived of all benefits to the fullest extent of law. All mailing charges and other charges reasonably related to the dues of said member, e.g. bank charges, shall be charged to the member. All remittances shall be made to the trustee payable to the association. A Member must notify the trustee in writing of any change of mailing address within five (5) days of such change. If a member so expelled desires to be reinstated, he must make application and meet the qualifications in the manner prescribed by the by-laws for a new member, provided such member shall pay an initiation fee equal to an amount derived by multiplying the number of whole years between the year of expulsion under this section and the year of reinstatement under this section by the appropriate amount pursuant to the table set forth immediately below.

### Article 3 Section 8
