CONDITIONS OF ACCOUNT

1. Any complaint as to incorrect charges for services performed must be made in writing within seven (7) days of receipt of the services otherwise the services to which the account refers shall be deemed correctly charged and performed.
2. Advanced Temporary Fencing Pty Ltd and/or Advanced Environmental Services Pty Ltd (hereinafter singularly or jointly called 'Advanced') source documents signed by any person you employ shall be prima facie evidence of the performance of services charged to this account. The condition of such services, details of the amount due and owing hereunder, and any other matter or fact set out in such source documents may be used in any Court proceedings.
3. Until such a time as notification to Advanced (in writing) of any change in proprietorship, or change in any other particular set out in this application, those named shall remain liable for any goods and/or services supplied or provided or otherwise charged to the within credit account.
4. This credit facility may be withdrawn by Advanced at any time, without prior notice.
5. If the Customer defaults in making payment to Advanced in accordance with these terms and conditions, or the standard terms and conditions of the Company as released from time to time, then Advanced may in its absolute discretion:
 - a. Charge the Customer interest calculated on the portion of the Customer's account overdue from time to time at the rate of 2% per month from the date on which such default arose; and
 - b. Require the Customer to reimburse Advanced for all collection costs including legal costs incurred by Advanced calculated on a solicitor and own client basis as a consequence of Advanced instructing its solicitor to provide advice to it in connection with each default and/or to institute such recovery processes as shall in the absolute discretion of Advanced be appropriate in the circumstances.
6. Any payments tendered by the Customer to the Company shall be applied as follows:
 - a. Firstly as reimbursement for any collection costs incurred by Advanced in accordance with Clause 5(b) hereof;
 - b. Secondly in payment of any interest charged to the Customer in accordance with Clause 5(a) hereof; and
 - c. Thirdly in satisfaction or part satisfaction of the oldest portion of the Customer's account.
7. Where services are supplied to the Customer on credit the Customer irrevocable authorises Advanced, its employees and agents to make such enquiries as it deems necessary to investigate the credit worthiness of the Customer from time to time including (but without limiting the generality of the foregoing) the making of enquiries of persons nominated as trade referees, the bankers of the Customer or any other credit providers (the information sources) and the Customer hereby authorises the information sources to disclose to Advanced such information concerning the Customer which within their possession and which is requested by Advanced.
8. At all times during and after the extension of this credit facility, the Customer will be subject to the standard Terms and Conditions of Advanced. A copy of these Terms and Conditions are available at any time upon request or can be obtained from Advanced's website.
9. The Guarantor unconditionally and irrevocably guarantees the prompt performance of all of the Customer's obligations which apply under this Agreement, irrespective of whether Advanced has first sought to enforce such obligations against the Customer. It is agreed and acknowledged that Advanced may recover monies from the Guarantor which the Customer owes Advance as a liquidated debt.
