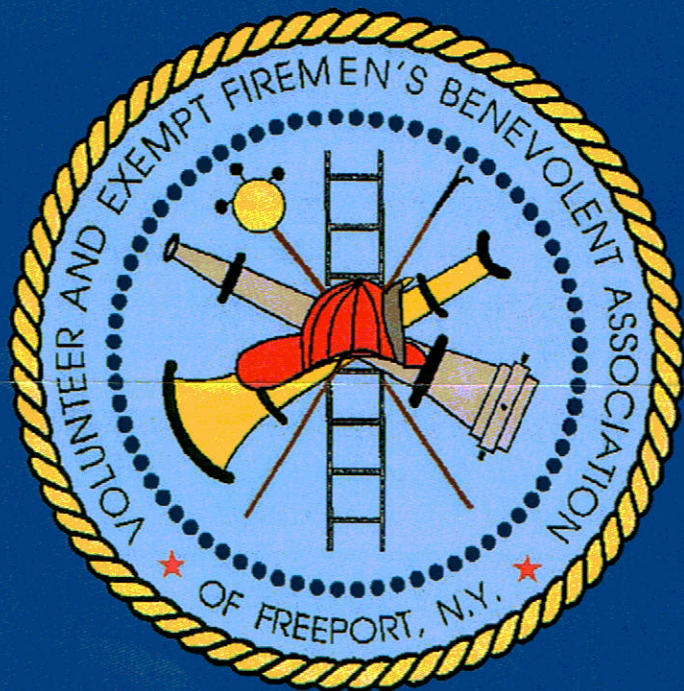

Benevolent Board of Trustees Elections

The elections for the five offices of your Association will be held on Tuesday, April 23, 2013 at 8:00 P.M. The elections will be held at 416 Atlantic Avenue, Freeport, New York. A Nominating Committee of three members has been appointed and any member who wishes to serve on the Board of Trustees should be guided by the following sections of our by-laws:

Article 4 Section 12

The president shall appoint three (3) members of the association to serve as the nominating committee at the January meeting of the board of trustees. All candidates shall submit to the nominating committee a signed, written letter of intent specifying the office sought and certifying as the qualifications of the candidate for the office pursuant to section 8 of article 5 not less than thirty (30) days prior to the annual meeting in order to appear on the written or printed ballot.

Nominations shall not be made from the floor during the annual meeting. The nominating committee shall report its recommendations at the board of trustees meeting on the fourth (4th) Monday in April and also at the annual meeting of the association on the fourth (4th) Tuesday in April.

Article 5 Section 8

No person shall be eligible for any office of the association unless and until he shall have been a member thereof in good standing for five (5) consecutive years, except the office of administrative clerk or administrative bookkeeper. Those members who seek office must submit a letter which is postmarked by twelve midnight of March 23, 2013.
